Parade Contingent Information

Please take the time to read ALL of the requirements listed below.

- Check-In – All units must check in at the parade headquarters on the day of the parade. Check-in is required so that the parade committee may verify that all required information has been submitted and/or collected, provided you with any necessary last minute instructions or changes, provide you with line-up instructions, and give you your parade order assignment. **Check in begins at 8 am.**
- Assembly Area – We go to great pains to logistically arrange the best line up for the parade that we can, to accommodate the logistics contingents required and give some groups at the back in previous years a turn at marching towards the front alternatively. We also need to take care of the very young children, puppies, elders, infirm, or differently disabled, by making sure they spend as little time in what can be unforgiving elements for them.
- Line Up – One of the things that Moorpark in particular enjoys is a very large and loyal crowd of watchers. You must remain in the same order as in the script or you will be announced under the wrong name and eliminated from judging.
- All car show participants must be staged and roll into position immediately following the last parade entry. All cars will stay in line and park parallel on the street as directed.
- All Participants must be in the staging area at their assigned location no later than 9:30 am.
- For Line Up - Proceed to Gabbert Rd, then right on Poindexter to Check-In Table. **Parade starts promptly at 10:30 am.**
- Closing up a Gap – You only need to slightly increase your step, still at a safe pace, in order to minimize a gap forming in front of you, or slow slightly to prevent a gap from forming behind you. No one – not a gap monitor; police officer, nor safety, medical, or parade personnel should ever encourage you to run and catch up.
- Stopping and Performing – In order for you to be able to stop along the parade route to perform, you need two things:
 1. Approval in writing from the Parade Manager and
 2. Development of a routine with a 30 second Maximum. This is also the routine you can use when you are allowed to stop and perform at the Grandstands, for the judges. Longer stops and routines are discouraged, since they create lengthy gaps and add to the duration of the parade.
 3. Never stop to perform for TV or other cameras!
- Safety Rule! Throwing or Handing Out Items to Spectators – It is unsafe, unsanitary and a violation of Moorpark Country Days rules to distribute any items (food or non-food) during the parade. Violations of this rule may result in the immediate withdrawal of a unit from the parade and a one-year suspension from the parade.
- The Moorpark Country Days Committee reserves the right to revoke participation of any group or individual that offends community standards for conduct at a family-oriented event, or that could endanger participants or spectators.
